#### Review

The National Institute of Social Development functioning under the Ministry of Home Economics, Microfinance, Self-Employment and Business Development is the only institution in Sri Lanka that provides social work education. Our institute was established in 1952. Our institute, which has become an institution of higher education by Parliament Act No. 41 of 1992, has been declared as an institution authorized to award degrees under Section 25A of the University Grants Commission Act No. 16 of 1978. Many courses are implemented such as social work, social welfare, social development and psychological counseling, and course on community based correctional for officers etc. Our Institute consists of three academic divisions namely School of Social Work, Training Division, and Research Division and Administration and Finance Division.

The National Institute of Social Development prepares and implements social work postgraduate, social work degree, social work advanced diploma, diploma, certificate and training and research programs to suit the national needs. The curriculums of these courses have been prepared after analyzing the information obtained from the needs assessment reports. These curriculums are designed with high quality as per the recommendations of the University Grants Commission.

School of Social Work is the oldest division of the National Institute of Social Development. This division offers degrees in professional social work and the National Social Development Institute is currently the only government institution in Sri Lanka that offers professional social work degrees. As a University Grants Commission approved degree awarding institution of higher education, School of Social Work currently conducts four major programmes namely, one year diploma in social work, advanced diploma in social work, bachelor of social work, master of social work. In particular, our institute's courses are based on practical field training along with theoretical knowledge, and through the development of knowledge, attitudes and skills in the participants it is expected to get their active contribution in policy planning as pilots in the field of social development.

The training division develops and implements training programs parallel to the subject of social work (Para Professionals). Also, training programs are organized and implemented according to the request of other government and non-government institutions. Therefore, the training programs of the training division are organized focusing on regional training centers and related areas. The training division of the National Institute of Social Development is making plans to start the graduate course and postgraduate courses in counseling which have not been started in any university so far. In this way, training programs are organized based on a wide range of fields. There, long-term and short-term training programs and courses as well as other professional courses are prepared according to the existing needs of the country and provide the trained labour required for social development. Moreover, the social development policy research and publication section of our institution conducts various researches and studies related to social work, social welfare and social development and publishes those research reports and academic books.



Also, social work research papers are published bi -annually in all the three languages and these publications are compiled according to international standards. Through research, proposals and recommendations are provided on how to conduct social work interventions to solve current social problems in Sri Lanka.

Also, in addition to these three academic areas, all these tasks are administered and managed by the administrative and financial division. Four regional centers affiliated to the institute are established and maintained in the areas of Anuradhapura (Talawa), Ampara, Hambantota (Ranna) and Kilinochchi and our institute's academic research and training courses are planned and maintained according to the needs of those areas based on these centers. A permanent building complex of 100,000 square feet is being constructed for our institute in Seeduwa area. This will give opportunities to promote the number of students enrolled for the studies of the institute and will be able to start and run new courses according to the existing needs of the country.

At present, our institution is producing social work professionals by producing the trained manpower required by the country based on the existing educational needs of the country and is engaged in community empowerment activities. Our institute is working to expand the objectives and tasks of the institution to the community by exchanging educational programs nationally and internationally, is currently performing a great task for the social development of Sri Lanka. Apart from this, you will be able to know all the information through our institute's website. I commendably state that the institution is currently playing a great role in empowering and leading the Sri Lankan community towards development.

## National Institute of Social Development Performance - 2021

#### 01. Introduction

The National Institute of Social Development established under the Act of Parliament No. 41 of 1992, started in 1952 as the "Institute for Social Work" with the participation of several voluntary organizations. When it was taken over by the government in 1964, it was renamed as Sri Lanka School of Social Work. Thereafter the National Institute of Social Development became a degree awarding institution under Section 25A of the Universities Act No. 16 of 1978, National Institute of Social Development.

#### Mission

"To enhance human resources for social development through the preparation of competent manpower in social work at all levels, generate and disseminate new knowledge and technologies for Social Work Practice, Provide Specialized Services for Social Welfare and Social Development."

Objectives of the Institute the objectives of the institute, as stated in the National Institute of Social Development Act. No. 41 of 1992 are to:

- 01. Upgrade, expand and update higher educational programmes for Professional Social Work, Social Welfare Management & Social Development up to the globally recognized standards.
- 02. Expand, strengthen, and collaborate in training programmes aimed at Human Resources Development for Social Welfare, Human Services, Community Development Empowerment of disadvantage and Social Development while increasing avenues for those who are interested in developing and advancing their skills in the field of Social Work to optimize and better perform their careers with competency.
- 03. Initiate, promote, conduct and collaborate in research work pertaining to various aspects of Social Work education and practices, Social Welfare and Social Development whilst generating and propagating new knowledge pertaining to the field for present and future application.

05. Improve financial, academic, non-academic manpower and infrastructural resources with special attention to the establishment of a permanent premises for the institute to facilitate the achievement of all other goals

#### The activities conducted by the National Institute of Social Development is as follows.

- 01. Conducting advanced courses in professional social work education, social welfare management and social development, promoting and taking them to an internationally recognized level.
- 02. Expanding and strengthening training courses, conducting them in collaboration with other institutions for the development of human resources for social welfare, empowering the underprivileged, providing a better standard of living to individuals through the development of human skills and professional skills.
- 03. Making progress in the field of social development through conducting, promoting and maintaining social work education, training and research related to social welfare and development.
- 04. To provide special contribution to formulate, plan and implement policies related to social welfare and social development.
- 05. Acquiring other resources including financial academic and non-academic manpower and infrastructure such as establishing a permanent location for the National Social Development Institute, which are required to successfully achieve all the above objectives to implement Social Welfare plans in Government and Non-Governmental sectors, assigning Social Work students to those institutions through their projects, providing necessary guidance and advice for their development, conducting consultancy meetings and conferences to make their services more productive.

\*\*According to the Cabinet decision taken on 31.08.2021, the treasury was informed that 3 million of the 10 million earmarked for capital expenditure as the amount expected to be saved from the budget allocations under the review of public expenditure will be spent and only the remaining 7 million will be spent. But out of this 7 million, only 5.6 million was given as cash.

#### Seeduwa Building Complex built for the National Institute of Social Development

An amount of Rs.1,000 million has been allocated for the building complex under construction for the National Institute of Social Development on the approval of the Cabinet of Ministers and its construction started in 201 The building complex consists of two buildings namely Wing A and Wing B. Wing B building is named as academic building and Wing A building as administrative building. A provision of 229 million rupees had been allocated for the construction of the building for the year 2021 and the amount spent on the building in the year 2021 was 121 million rupees. The construction work of the building is being done by the State Engineering Corporation and as of December 2021, Wing B building has shown 96% physical progress and Wing A building 67%. From 2020, academic and administrative activities of the institute are being conducted in the Wing B building.

The School of Social Work is the largest and oldest division of the National Institute of Social Development. This division conducts professional social work degree programmes. The School of Social Work is the only government institution in Sri Lanka which offers Professional Social Work degrees in Sri Lanka and it is a higher education institution recognized by the University Grants Commission. Currently, the School of Social Work is implementing three main programs namely, one year Diploma in Social Work, Higher Diploma in Social Work, Bachelor of Social Work and Masters in Social Work. #### Introduction to Master's Degree Programme in Social Work

The Master's degree programme in Social work aims to produce professionally qualified and managerially competent work force to service the social welfare system and thereby promote Social development. The program is designed to provide participants with an advanced knowledge in social work and to provide practical training to change attitudes so that they can actively participate in policy making as leaders in the field of social development.



#### Subject content of the course


The curriculum of the Master's Degree consists of subjects related to social sciences as well as courses related to the subject of social work. Students should also complete two field trainings and a research dissertation to gain theoretical knowledge as well as practical knowledge. Subjects such as Sociology for Social Work, Psychology for Social Work, Philosophy of Social Work, Understanding Sri Lankan Society, Social Welfare Programs in Sri Lanka Globalization and Social Welfare, Social Work and Human Rights, Social Work Management, Social Policy, Research Methods for Social Work as well as basic field training and community work and research dissertation and provide students with the opportunity to gain practical knowledge and skills.

These programmes are designed according to the Sri Lanka Qualification Framework and are offered with an international standard scoring. Therefore, the students who have completed the Master's Degree in Social Work at our institute have a high level of potential for employment abroad.

#### **Bachelor's Degree in Social Work**

The Bachelor's Degree in Social Work is a 4-year full time course. It consists of 08 semesters, classroom lectures and three concurrent field placements. The Bachelor Social Work in particular is a unique programme because it offers not only theoretical knowledge but also practical training unlike any other degree course offered by other universities in Sri Lanka. During classroom lectures, students are attached to field trainings to change their knowledge and attitudes, and field activities are conducted under the guidance and supervision of field supervisors and faculty supervisors.

The syllabus of this Bachelor's degree course consists of subjects of social sciences as well as specific courses of social work and provides students with a comprehensive knowledge. It is also mandatory for students to engage in community activities through field training, and to prepare reports on those activities. In addition, students should conduct research, plan and launch activities based on the findings, and prepare a research report.


1. Social work day on March 09, 2021



#### I am because we are: Strengthening Social Solidarity and Global Connectedness

World Social Work Day falls on 16<sup>th</sup> of March. The theme of this year's Social Work Day is "I am because we are": Strengthening Social Solidarity and Global Connectedness. This is a theme built on the basis of Ubuntu, an African ideal. Why is it important not only for countries in the African region but also for other countries? Who are we because of me? Why is this value important in managing an epidemic situation like COVID 19? It is important to prepare for the challenges of the future world by thinking again and again about the new lessons that have been shown to us due to the Corona epidemic.

On March 9<sup>th</sup> 2021, National Institute of Social Development in collaboration with the SERVE Organization of Moratuwa conducted activities with the participation of the community. The Director General of the National Institute of Social Development, Shamini Attanayake, the directors and the academic staff participated in it. #### **Programme on Service Delivery in Human Settlements 2021**

The rural camp conducted by the third year students of BSW 2018/2017 batch was organized from March 24<sup>th</sup> to April 04<sup>th</sup> in Chilaw. This program was conducted covering the villages belonged to the Chilaw Divisional Secretariat. 01. Webinar on using soft tools and the use of art to solve social problems





Due to the social problems that the entire society is facing, a huge negative impact on individuals, groups and communities can be seen. This program was held on 06 July 2021 from 7.00 pm to 9.00 pm. Social work professionals and social work students also participated in this.

This discussion focused on the role of social work professionals in natural disasters and man-made disasters, where community awareness on how to manage disasters through therapeutic, preventive and developmental approaches and how the social work professionals should act as a mediator were discussed.



# **Training Division**



#### Introduction

The Training Division established in 2004 is one of the four major divisions in the institutional structure of the National Institute of Social Development. This division operates under a Training Director. Two Senior Training Officers and 08 Training Officers of Grade 1 are working in this division. In addition to this, one Management Assistant of Grade I, two Management Assistants of Grade II, one Management Assistant of Grade III and an Office Assistant are employed in this Division.

This course was started on 27.01.2019 at the main center of the National Institute of Social Development, Colombo. At present, the students of the advanced diploma course have been assigned for field training.

Diploma in Counseling is conducted as a weekend Programme conducted by the Training Division of the NISD. This Diploma is designed in par with the Sri Lanka Qualification Framework of the UGC.

- To enhance the professional skills of counseling professionals.

21 months. This course includes 3 months of counseling training. (Weekend course)

#### 3. Diploma in Gerontology and Elder Care

#### Introduction

Diploma in Gerontology and Elder Care course was designed for the persons who are already employed in the field of Elder Care and who wish to develop knowledge and skills necessary to work with the elderly. This course aims to produce skilled professionals who can work with the elderly community. The course content includes a multidisciplinary knowledge base to equip the participants with necessary competencies to develop their carriers as caretakers.

This diploma is designed as a part time Programme in par with the Sri Lanka Qualification Frame Work of the University Grants Commission and the Quality Assurance Unit of the Ministry of Higher Education with the aim of offering a recognized qualification in the field of elder care nationally and globally.

#### Aim

To create a group of experienced professionals with knowledge, skills, attitudes and mental structure who wish to work in the field of Geriatrics and Elderly Care and to develop the professional capacity of individuals who wish to work in this field.

2. Telephone counseling service conducted by the Training Division introduced during the COVID19 Pandemic


#### Introduction

# Introduction



#### Introduction



5. Online short term training program on application of basic skills in social work practice



#### Introduction

The online training program on the use of basic skills in social work training was conducted for the newly appointed Development Officers. The program was conducted in both Sinhala and Tamil media and the Sihala media program was conducted from July 12<sup>th</sup> to August 9<sup>th</sup> of 2021 and the Tamil media program was conducted from July 13<sup>th</sup> to August 10<sup>th</sup> of 2021. # Introduction



- To distinguish between a research objective and a research proposal
- To identify the elements of a good proposal

In this program, two research proposals submitted by the National Institute of Social Development were reviewed. The program was conducted using the interactive method with participants from all three divisions of the National Institute of Social Development and the participants' research knowledge and experiences were shared effectively. It was also discussed how to state the findings of the study in a research proposal and what to consider in it. The next focus was on measuring the strengths and weaknesses of a research, and it was explained how to focus on developing a research topic. Finally,



the positive aspects of several research proposals presented by the institute were further considered and the points that need to be changed were discussed.

The program received good feedback and it was said that the practical knowledge gained through these sessions was very important for them to overcome the challenges of their professional life and intervene in the development of the youth community. They were also of the opinion that there is a need for these programs for their officers and that such programs should be organized for the youth community.



# 18. Conducting a short term training programs for Family Counselors attached to the Ministry of Justice (MoJ) under the Judicial Service Commission (JSC).

#### Introduction

This training program was designed as an in-service training program for Family Court Counselors appointed by the Judicial Service Commission (JSC) with the objective of enhancing the capacity of Judicial Family Counselors appointed by the Judicial Service Commission. This project consisted of two phases.

- 1. Initial Stage: Preparing a syllabus and printing it as a training manual
- 2. Stage Two: Conducting training for family court counselors based on the developed curriculum.

The first phase was conducted from May 2020 to December 2020 as a collaborative initiative between the Judicial Service Commission, National Institute for Social Development and Asia Foundation. # Regional Training Center Thalawa Progress report for the year 2021

#### 1. Introduction

The Thalawa Regional Training Center of the National Institute of Social Development is located in the Moragoda Grama Niladhari Division of Thalawa Divisional Secretariat in the Anuradhapura District of North Central Province. It is located facing the Anuradhapura-Kurunegala main road, 2km away from Thalawa town towards the city of Anuradhapura.

At present the Thalawa Regional Training Center owns approximately 05 acres of land and consists of a two storied building. In the ground floor of the main building there are 02 office rooms and 02 small accomodation rooms with 02 detached rooms with 35 beds and a dining room. In the upstairs there are 02 small accomodation rooms and 01 VIP room with a lecture hall.

# 2. Establishment of the Centre

The foundation stone was laid to this building complex of the National Institute of Social Development by her Excellency Chandrika Bandaranaike Kumaratunga, President of the Democratic Socialist Republic of Sri Lanka on February *26*, *1999* with the participation of the Hon. Speaker of the Parliament of the Democratic Socialist Republic of Sri Lanka, Dr. K.B Ratnayake and with the invitation of the Hon. Burty Primalal Dissanayake Minister of Social Services, Member of Parliament, Anuradhapura District.

#### 3. Objectives of establishing the Center

This center was opened by the Hon. Ravindra Samaraweera, Minister of Social Welfare on 31<sup>st</sup> March 2002. The purpose of establishing this Thalawa Center was to provide Social Work Education, Training and Research to the area through this center and to provide assistance to the area for improving the quality of life of people in the area.



#### 4. Vision of the Regional Center

To be an active partner in promoting the quality of life of all as a branch of the Center for Excellence both locally and internationally in the field of Social Work Education Training and Research.

## 5. Using as a Residential Center

The Talawa Regional Training Centre of National Institute of Social Development is also used for residential purposes. The main building has 01 VIP room (air conditioned) and small rooms (with 02 beds). In addition, accommodation can be provided for 37 persons. The main lecture hall (60x30 feet) has about 80 seats.

The dormitories of the Center are used for training programms for both public and private sector as well as for residential needs at rates fixed by the institute. This provides additional revenue to the institute as well as a great service at the national level. Also, the Thalawa Regional Training Center is the only Centre in the National Institute of Social Development that provide accommodation for field students as well as field study tours and training programmes. The Regional Centre has also become a great resource for student education by providing residential facilities to those students who come from far away places to participate in the Diploma & Higher Diploma Programmes conducted by the NISD.

This research publication has been prepared based on the findings of several selected research conducted by the research division on the topic of social problems of the contemporary Sri Lankan society conducted at national level. This publication is based on the initial findings of the Study on Current Status of Child Care Institutions and Institutionalized Children in Sri Lanka- Situational Analysis, Preliminary Study on the Situation of Elderly Population: Institutionalized Care System in Sri Lanka, Research on the causes of poverty in Sri Lanka, Research on investigating interventions to improve the family well-being of patients with chronic kidney disease and the Research on the effects of modern Teledrama on family institution.

**1.** Financial Statements

1.1 Qualified Opinion

\_\_\_\_\_

The audit of the financial statement of the National Institute of Social Development for the year ended 31 December 2021, comprising the statement of financial position as at 31 December 2021 and the statement of comprehensive income, statement of changes in equity and cash flow statement for the year then ended and notes to the financial statement including a summary significant accounting policies, was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with provisions of the National Audit Act, No. 19 of 2018 and Finance Act No.38 of 1971. My report to Parliament in pursuance of provisions in Article 154(6) of the Constitution will be tabled in due course.

In my opinion, except for the effects of the matters described in basis of qualified opinion section of my report, the accompanying financial statements give a true and fair view of the financial position of the Institute as at 31 December 2021 and its financial performance and its cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.



#### 1.2 Basis for Qualified Opinion

\_\_\_\_\_

(a) The Course fees received for 02 bank accounts from February to November of 2021 which amounted to Rs.3,187,360 had been included as deposits in the financial statements without recognizing and accounting the said amount as revenue.

Due to this reason, the financial statements of the year under review showed a deficit.

(**b**) As the due course fees of the previous year and the year under review had been calculated more than the real amount, a balance of Rs.8,117,626/- had been included in the Financial statements.

Due to this, the mobile assets and the balance brought forward at the end of financial year under review indicated more than the real amount.

I conducted my audit in accordance with Sri Lanka Auditing Standards (SLAuSs). My responsibilities, under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

#### 1.3 Other information included in the annual report of the Institute for the year 2021

\_\_\_\_\_

Other information means the information contained in the annual report of the Institute of the year 2021 obtained by me, prior to the date of my audit report but not included in the financial statements and my audit report thereon. The management is responsible for this other information. Other information does not cover from my opinion in respect of the financial statements and I do not express any opinion or assurance thereon. My responsibility related to my audit on financial statements is to consider whether other information is materially inconsistent with financial statements or in accordance with my knowledge obtained in audit or through other methods and reading the above identified other information when it is made available.



If I conclude o the basis of other information obtained prior to the date of this report and the functions performed by me that the other information is materially misstated, that matter needs to be reported by me. I have no such matters to be reported in this regard.

1.4 Responsibilities of the Management and those Charged with Governance for the financial Statements

Management is responsible for the preparation of financial statements, that give a true and fair view in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as management determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing financial statements Management is responsible for assessing the Institute's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Institutes or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Institute's financial reporting process.

As per Sub-section 16(1) of the National Audit Act, No. 19 of 2018, the Institute is required to maintain proper books and records of all its income, expenditure, assets and liabilities, to enable annual and periodic financial statements to be prepared of the Institute.

.15 Auditor's Responsibilities for the Audit of Financial Statements

My objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an Auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Sri Lanka Auditing Standards will always detect a material misstatement when it exists.



Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Sri Lanka Auditing Standards, I exercise professional judgment and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Institute's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the management.
- Conclude on the appropriateness of the management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainly exists related to events or conditions that may cost significant doubt on the Institute's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate to modify my opinion. My conclusions are based on the audit evidence obtained upto the date of my auditor's report. However, future events or conditions may cause the Institute to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements



represent the underlying transactions and events in a manner that achieves fair presentation.

I communicate with those charged with Governance regarding among other matters, significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

2. Report on Other Legal and Regulatory Requirements

- 2.1 National Audit Act, No.19 of 2018 includes specific provisions for the following requirements.
- 2.1.1 Except for the effect of the matters described in the basis for qualified opinion paragraph, I have obtained all the information and explanations that required for the audit and as far as appears from my examination, proper accounting records have been kept by the Institute as per the requirement of section 12 (a) of the National Audit Act No.19 of 2018.
- 2.1.2 The financial statements presented is in consistent with the preceding year as per the requirement of section 6 (i) (d) (iii) of the National Audit Act No.19 of 2018.
- 2.1.3 The financial statements presented include all the recommendations made by me in the previous year as per the requirement of section 6(i)(d)(iv) of the National Audit Act, No.19 of 2018.
- 2.2 Based on the procedures performed and evidence obtained were Limited to matters that are material, nothing has come to my attention.
- 2.2.1 To state that any member of the governing body of the Institute has any direct or indirect interest in any contract entered into by the Institute which are out of the normal course of business as per the requirement of section 12 (d) of the National Audit Act, No.19 of 2018.
- 2.2.2 To state that the Institute has not complied with any applicable written law, general and special directions issued by the governing body of the Institute as per the requirement of section 12 (f) of the National Audit Act No.19 of 2018 except for the following; Reference to Laws/ direction Observation

Financial Regulation 396(d)

Although the expired cheques needed to be cancelled and accounted as a due payment , 38 cheques worth Rs. 154,702/- of 02 accounts had not been cancelled and accounted even after 06 month of expiry.

- 2.2.3 To state that the Institute has not performed according to its powers, function and duties as per the requirement of section 12 (g) of the National Audit Act, No.19 of 2018.
- 2.2.4 To state that the resources of the Institute had not been procured and utilized economically, efficiently and effectively, within the time frame.
- 3. Other Matters

- (a) Actions had not been taken to charge an amount of Rs.8,378,054/- until 31<sup>st</sup> December 2021 from the course fees to be charged from 2017 to 2020 which was shown in the Accounts as Rs.16,495,679/-.
- (b) Although about Rs.30 million had been kept in 02 current accounts from 2016 without utilizing until the financial year under review, no actions had been taken by the institute to invest the said funds productively to generate an additional income.

The report including the Director General's comments regarding the observations contained in Report of the Auditor General on the Financial Statements and Other Legal and Regulatory Requirements of the National Institute of Social Development for the year ended 31 December 2021 in terms of Section 12 of the National Audit Act, No. 19 of 2018.

#### 1.2 Basis for Qualified Opinion

- (a) All deposit receipts including Course fee receipts of Rs. 3,187,360 in both accounts during the period from February 2021 to November 2021 have been recognized and accounted for in July 2022 and previous months. At present, an internal system is being implemented to identify and account for all deposits including course fees so that unrecognized amounts do not arise in the future.
- (b) As the course fees receivable were over calculated in the previous year, course fees receivable at the end of the year under review had been overstated in the financial statements by Rs. 8,117,626. This is receivables from the students who left the courses up to the year 2020. But since the students have left the course, this balance amount will not be received. I will get the approval of the governing council and remove it from accounts receivable. These accountings are due to the non-revision of the budget estimates prepared for the course. In the future, before preparing the final accounts, I will revise all the course budget estimates after including the regular number of students and take actions to account for the correct income and receivables.
- 2.2.2 All the overdue cheques of the both the accounts for the year 2021 have been taken as an income and I will also take action to take 06 months overdue cheques as an income.

#### 2.3 Other matters

- (a) Out of this Rs. 16,495,679, a sum of Rs. 8,378,054 is the amount due for Master of Art (MSW) degree (2018/20). The amount is to be received in the year 2022 and the following years. The fee of Master of Art degree is Rs. 227,000, out of which the first installment is Rs. 127,000 had been collected from all the students and the remaining amount is to be received before the final examination of the students.
- (b) A fixed deposit of 25 million was opened on 30 December 2021 and the money in that account was used to generate additional income for the institution.
